CIRCULAR LETTER NO. 25

Training of Medical Department in Chemical Warfare

Medicine - - - - - Section I
Rescission of Current Directives - - - - - Section II

SECTION I. TRAINING OF MEDICAL DEPARTMENT IN CHEMICAL WARFARE
MEDICINE

1. General. The constant threat of the use of Chemical Warfare by the enemy requires continued training in Chemical Warfare Medicine. Special emphasis should be placed on first aid against chemical agents. The complete understanding of first aid against chemical agents is a military necessity and must not be minimized because the enemy has not as yet used gas. It must be stressed that each individual in the army is responsible for his or her own first aid against chemical agents. It is too late to teach first aid after gas has been used.

2. References. Principles of Chemical Warfare Medicine and first aid against chemical agents are covered in:

3. Objectives.

- a. Proficiency of every individual in first aid against chemical agents.
- b. Proficiency of every medical officer in all phases of Chemical Warfare Medicine.



4. Responsibility.

a. Individual:.

(1) Complete understanding of first aid against chemical agents.

b. Medical Officers:

(1) Complete understanding of Chemical Warfare Medicine including first aid.

(2) Knowledge of standing operating procedure for care and handling of gas casualties.

c. Unit Commander:

(1) That each individual is properly trained as indicated in "a" and "b" above.


SECTION II. RESCISSION OF CURRENT DIRECTIVES
